1. Fill out Field request form, print legibly, — Page 2, one form per field. To be used for all fields.
2. If Concessions/Vending Services are requested, a separate Event/Concession Rental Request form must be completed and applicable vendor and Health District application and fees must be paid to the appropriate Departments.
3. Spring & Summer Sports Season: April 1<sup>st</sup> – June 30<sup>th</sup> **and** July 1<sup>st</sup> – September 1<sup>st</sup>
  - **Deadline for requests is March 1<sup>st</sup> for both seasons**Fall Sports Season: August 15<sup>th</sup> – November 11<sup>th</sup>
  - **Deadline for requests is July 1<sup>st</sup>**
  - **Fields will be closed on November 11, 2019 and will be unable to be rented past this date.**
    - **Scalise Field will be closed from June 6<sup>th</sup> to September 1<sup>st</sup>, 2019.**

**All requests will be processed on a first come first serve basis consistent with priority group classifications as described in the *Field/Facility Use Policy*. Requests can be emailed in to Terri Noyes at [tnoyes@town.berlin.ct.us](mailto:tnoyes@town.berlin.ct.us).**
4. Confirmation of requests via a field permit will be returned to the attention of the contact person provided on this form. No request will be finalized until request form is complete, roster provided with copies of licenses, payment is received and applicant is in receipt of a permit.
5. Permit holders are responsible for reviewing the *Field/Facility Use Policy*, and the *Confirmation Reservation Receipt*, carefully. Some requested dates may not be available.
6. All changes, postponements and cancellations must be arranged and confirmed in writing or through email only to Terri Noyes at [tnoyes@town.berlin.ct.us](mailto:tnoyes@town.berlin.ct.us), and CC Jen Ochoa at [jochoa@town.berlin.ct.us](mailto:jochoa@town.berlin.ct.us). If you are utilizing Public Grounds staff for your event, you must notify Steve Karp, Superintendent of Highway & Public Grounds at 860-828-7047, (work hours are 7:00AM – 3:00PM) four (4) hours prior to your event in order to avoid those costs. Steve Karp can also be reached through the Berlin Police Department at 860-828-7080.
7. **You must specify on your application if you are using the field for a game or practice.** This is important for our Public Grounds staff to know in regards to treating the fields.
8. Important Specialty Field Information:
  - Zipadelli Field is now a Local Baseball Field only (see Field/Facility Use Policy for definition of Local).
  - Rental of Scalise Field also requires a Public Grounds employee for length of rental and user is responsible for payment of that employee. (Non-local/For Profit groups)

A permit will not be granted until payment is received for use of the field.** Key agreement form (Schools and Youth Leagues) must be signed when receiving keys. Keys given out must be returned within one month of the end of your reservation or your deposit will be forfeited. Non-local youth and adult groups can request a field box key. A \$50.00 deposit and a signed key agreement are needed. Deposit will be returned upon completion of reservation if all previous conditions and fees are paid.
