

BERLIN COMMUNITY CENTER ROOM RENTAL COVID-19 WAIVER

This waiver/release must be signed by all who utilize a room at the Berlin Community Center, or if under 18 signed by a parent/guardian on their behalf, and shall remain valid and in full force and effect until 6/30/2021.

By signing this form, I represent and affirm to the Town of Berlin that:

I am over the age of 18.

All minors (children under the age of 18) shall be supervised by the group contact or their designee while in the Community Center.

I am in good health, with no symptoms of COVID-19, no known exposure in the past fourteen (14) days to anyone who has tested positive for COVID-19, have not travelled to an Affected State in the past fourteen (14) days (or have received a negative test result for COVID-19 within 72 hours prior to or since returning to Connecticut) and no medical conditions that place me at increased risk for severe illness from COVID-19. If I develop symptoms of or am exposed to someone having symptoms of COVID-19, I will not use this facility. I understand that people living in households with individuals who are 65 years and older OR have higher risk for severe illness from COVID-19 are recommended to stay home.

I hereby attest and agree that while inside the Berlin Community Center, I will adhere to and comply with the rules and policies set forth by the Town, will adhere to and comply with all guidelines published by the United States Centers for Disease Control and Prevention (CDC) and the State of Connecticut pertaining to protection against Covid-19 and I will, at all times, follow the guidelines published by the State of Connecticut to avoid exposure to and protection against COVID-19.
